THE FORMULATION OF A TESTIMONY

In one of our previous editions of Prophetic Voice Magazine, we tried to distinguish between testimony and the witness. Testimony is just a word that means reporting what a witness has experienced, seen, or felt. When the prophet declared that the theme and spiritual focus for 2023 was the year of testimonies, the applied implication was that people would experience the unusual visitation and intervention of the supernatural. But like Mary asked in the Bible, how might this be? Is there a process by which testimony could be formulated?

Every product must go through a process, the idea, design, production, and product. To achieve an outcome, there is a need for knowledge of the process, called know-how or formula. The same applies to spiritual things that must be actualised in the material world. I am of the firm belief that Christianity is not guesswork but a functional relationship with a practical God of love who has already given us all things for our comfort, according to (2Peter 1:3-4), “According as his divine power hath given unto us all things that pertain unto life and godliness, through the knowledge of him that hath called us to glory and virtue.” It is clear from the preceding scripture that we have all that we require so that we would not struggle, as the world does, in

corruption. Why do we still fall short of divine interventions and testimonies? The answer to this question is in what I call the “spiritual formula of testimonies.” Can a testimony be procured, and if yes, by what and how can this be done? There is a formula that would bring testimony to fruition when known and applied.

The Formula: From a Word to a Testimony

During a Wednesday Testimony Clinic teaching, prophet Richard Amoaye shared that stated that the word of God is a seed. Once God has spoken, it is done. (Genesis 1:3). As humans, we speak and begin to work out what we have said. But God works differently. Indeed, he works in reverse order. He speaks only when he has finished. We must understand how the word of God works out as a testimony in our lives. He postulated that as far as God is concerned, once He has spoken, the matter is settled. (Psalm 199: 89) says that “Forever or Lord thy word is settled in Heaven.” He continued in his teaching, submitting that the seed, which is the word of God, represents the ideas that flow from God to produce the desired results. In Jeremiah 29:11, God says, “For I know the thoughts that I think toward you, saith the LORD, thoughts of peace, and not of evil, to give you an expected end.” The thoughts of God are the same as His ideas, and His ideas are captured in His words, and the words of God are His works. God does not speak about what He has not done. So, when we read or hear the word of God prophetically declared, the same word becomes to us the seed of our testimony. Paul explains this in (2Corinthians 9:9 – 10), saying, “Now he that ministered seed to the Sower

As it is written:

“They have freely scattered their gifts to the poor; their righteousness endures forever.”[a]

10 Now he who supplies seed to the sower and bread for food will also supply and increase your store of seed and will enlarge the harvest of your righteousness. -

2 Corinthians 9:9-10

both minister bread for your food, and multiply your seed sown, and increase the fruits of your righteousness.” From the preceding scripture, God gives seed(ideas) to the Sower, which produces the bread(result) for the eater. Looking at the underlined end of the scripture, you will notice that the seed received must be sown. And this is where the disconnect in applying the formula of testimony is. This is because, most times, the spiritual formula of testimony is misunderstood or misapplied. The prophet continued in his teaching, citing the book of (Genesis 8:22), “While the earth remaineth, there will be seed time and harvest.” He said this scripture is often misunderstood to mean there shall be seed and harvest times. He submitted that the rendition should have been “as long as the earth remains, there shall be Seed, Time, and then Harvest. The understanding of this gave us the formula for harvest or testimony: Seed divided over time is equal to harvest and, therefore, testimonies, i.e. (Seed/Time = Harvest). How do you work out this formula?

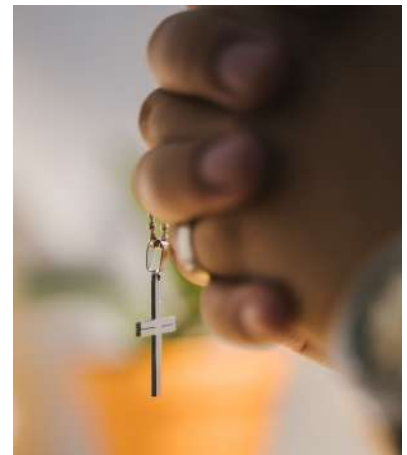
He further submitted that God is not subject to time, but

we are, as humans, to regulate our activity and measure work or effort. Though God is not subject to time, He has subjected the earth to time. So, if you are alive on this earth, your activities are regulated by time and influenced mainly by time. This is why between the seed, which is the word of God, is the time before the harvest, which is your testimonies. Therefore, in this formula, time is the common denominator. So, time is the most critical tool in the formula of a testimony. God's responsibility is to create your testimony, evidenced by His word. It means that once you can hear God speak concerning anything, He has already created that thing. However, it is our responsibility to apply the tool of time to the word for the physical manifestation, which will eventually give birth to our testimonies. The book of (Philippians 2:12) is written, "Wherefore, my beloved, as ye have always obeyed, not as in my presence only, but now much more in my absence, work out your salvation with fear and trembling. For it is God, who worketh in you both to

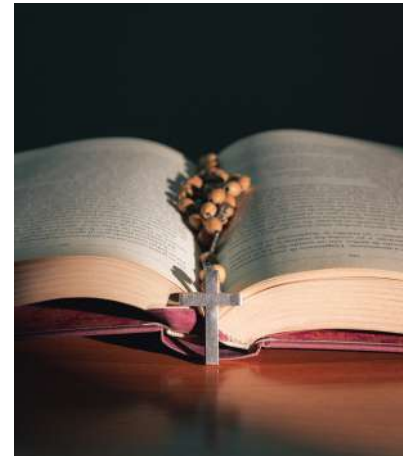
will and do of his good pleasure.” Paul, in this scripture, was handing down the secret of the workings of the power of God in our lives. God, in His love, wants us to partner with Him by obedience, evidenced in the application of time to the word of God to manifest what God has provided and given us the grace to manifest. But why so? Because God lives in the timeless dimensions known as infinity, which means He dwells in a measureless, limitless space and from there, He orders all creations into manifestation. But our human existence is limited and definite, regulated by time, so our approach to manifestation differs.

To further explain this formula, the prophet cited the book of (Genesis chapter 1:26). “And God said, Let us make man in our image, after our likeness; and let them have dominion over the fish of the sea, and over the fowl of the air, and over the cattle, and over all the earth, and over every creeping thing that creepeth upon the earth. So, God created man in his own image, in the image of God created he him; male and female created he them”. Then, in the same book of (Genesis chapter 2:7), it is recorded that “And the Lord God formed man of the dust of the ground and breathed into his nostrils the breath of life, and man became a living soul. In a comparative study of the two preceding scriptures, the prophet, in his teaching, revealed that Man existed before he was formed. In his first existence, he was in the thoughts of God expressed by the word of God; (And God said, let us make man in our image, after our likeness (the word); So, God created man in his own image, in the image of God

created he him; male and female created he them (existence). As God spoke, man was already in existence. However, God must apply Time and work for the man to manifest upon the face of the earth. So in chapter 2 of the same book of Genesis, it was recorded, “And the Lord God formed man of the dust of the ground”. This could be rendered as “and the Lord God worked on His idea of a man using the dust of the earth as His raw material until man became a reality on earth. Thus, the formula; Word = (the seed) + work/(Time) = Testimony/(Harvest). Therefore seed +Time = harvest (Genesis 8:22). The seed, the word of God, needs action over time to manifest in testimonies. Seed without action over time will not produce anything; it will die. (James 4:19 – 26) puts this formula clearly and succinctly when he says, “..... faith without works is dead”.

Conclusions

Prophets, pastors etc., are vessels for the release of the word from God, which is the seed of your testimony. Once God speaks, the formula is initiated. (Ecclesiastics chapter 3), In the fullness of time, God makes all things beautiful. For every word that must manifest upon the earth’s surface, there must be the full application of time to process such a word into reality. So, there is a processing of time for every word God speaks to blossom and bear the fruits of testimonies. This process of manifesting the word takes action toward the word received. Anyone who receives the word has been chosen by the word after all due consideration of many

things, including temperament, dispositions, and the inbuilt virtues. So once the word is spoken, it cannot return to God unless it has been performed. So do not say or think that you do not have what it takes to action the word of God. If the word is directed to you, then He, God, has already built in you what it takes to action the word into a tangible result and testimony. However, if the word is spoken and not received by the chosen, it finds another vessel and the process of the formula is aborted in the earlier vessel.

When the word is revealed, the word must be received and planted. Once the word is received and planted, it directs your actions and disposition. The main qualities that the word searches for are the faithfulness and obedience of the receiver. However, too many people have received and aborted the word because of a lack of faith and obedience. Without the necessary action, the word would be aborted, and there would be no testimony. This is what (James 2:26) means when it says, “..... faith without works is dead”.

It is our firm conviction, as declared by the prophet that it is our year of testimonies. Therefore, Today, if ye will hear the word spoken in your direction, harden not your hearts through in-action but rather work the word applying the formula of testimonies, and indeed in the fulness of time, the faithful God will make all things beautiful, and you shall testify.

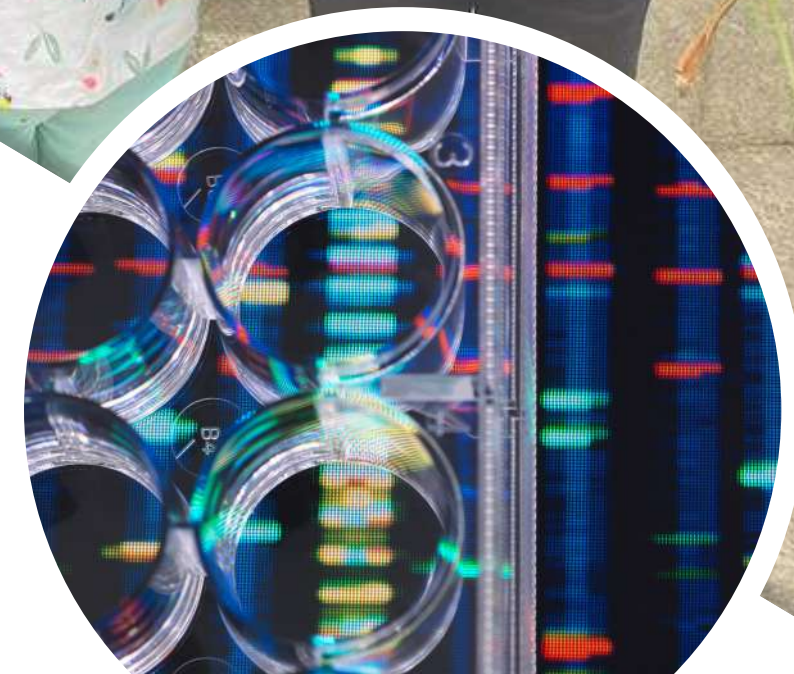


My name is Suzie and I would like to share a testimony of what God has done in our family's lives. This began in 2021 around November when I applied for Australian passports for my children. I have 4 children and the application was for all of them. I submitted the forms and the payments that were required. The process is supposed to take about two weeks. By January I had not heard from them, and I called to see what was happening with my kids' passports. They told me that they were still going through the process and they had not explained what was going on. So, from November till February there was nothing. March and April came too and then I received an email from them asking me to provide more documents and fill in more forms. I waited another 3 months, this turned into 7 months and still nothing. So, I went to the city office to ask what the problem was because I knew this was not normal. They said that someone would contact me and finally someone did call.

They said that the passports had not been issued because

they contacted my ex-husband, but he had claimed that the children don't belong to him, and he hung up. Because of that they could not issue the passport. When they tried to contact him again, they could not reach him. The agency told me that because of this a DNA test was needed. I tried to reach my ex and he said that he would not do the test and would not answer the phone anymore. I just laughed and said the God of Amoaye is alive.

The agency tried again but could not get him and I had to explain to the lady from the agency that the person they were dealing with was difficult. I didn't even know

I told them there was nothing else I could do. At this point I had given them everything they needed that I could provide...

where he lived, and he doesn't give me his address. We only meet once every 6 months or so, or, when he feels like seeing the kids, then he will disappear. So, I told the agency the truth. They sent me another form to fill and explain the situation and I took this to my sister to help me because it was stressful. So many forms in one year and they kept asking me to send more documents – another copy of a birth certificate, citizenship or there was silence, and we would just be waiting. After that they got in touch again asking for copies of my ex-husband's passport copy which I emailed.

I sent the passport copy to the Passport Department. The officer working on my case called me back again and she said that when she checked, the passport didn't exist. I didn't know the meaning of it and she asked where I got this passport. I told her that this was what my ex-husband sent but she said on their system it was cancelled five years ago. Because of this and the fact that they could not find his details, they could not issue my children's passports. This was now in October 2022.

I told them there was nothing else I could do. At this point I had given them everything they needed that I could provide. In December, on Monday the 12th, 2022, I decided to visit the office in the city. I felt that I had to take my son Richard, he didn't go to school on Monday. I took him as a present and I said to God, if you can make decisions on dates, I know you can issue the passport. We got to the office in the morning, and we took the train.

When we got there, I told the lady at the service area that I wanted to see the manager. She looked in the system and said she could see that they had contacted me, and everything was on our system. In my heart I was telling God that as Richard had gone with me that day it would be the sign that I would get to speak to the manager. I went by faith because they had told me many reasons why they could not give the passports.

At first it was because my ex-husband had not done the forms. Now it was that he had to provide DNA if he claimed that the kids were not his. At this point his phone was off and they were saying they needed his passport that was not expired, or they could not do

anything. When we were in the office, Richard was just standing by the window. The lady said that "oh your son is so cute". So instead of talking about the passport I began to tell the manager that this child is a gift from God, and I began to tell her my story about what God had done for me and in the life of Richard. This was while she was working on her computer. She was just listening, and she said to me "you are a blessed lady". After telling her the story in less than 20 minutes she said to me, "leave it with me and I will call my senior manager who is in a different department so we can see what we can do". So, Richard and I left it with her.

That same day the lady called me at 3:00 and we spoke for about 14 minutes. She said that she would send the children's passports to a different department in Canberra and they would make the decision about whether to give the passport or not. She asked a lot of questions and I gave her whatever she needed. Then on Tuesday the 13th, a different client officer called around 8:46am and she was telling me that we are going to put all the forms together. But before they could do that, they needed new passport photos because the files had been there for 9 months already, and they needed new photos for two of the kids. So, I did this, and she instructed me to post back to them which I did.

On Friday the 16th of December 2022, they called me again around 1:35 pm to tell me that the passports had now gone from Canberra to Melbourne which is where they have a different department manager that would make the decision. She was the manager that deals with issues like this because the other departments could not make decisions

I did not hear from them for some time. December came to an end and that marked one year since I had made the application for passports.

It was only this year in 2023 that the lady in charge of my documents called from Melbourne.

This year in January after the public holidays, exactly on the 4th of January she called me and she said to me that she sent an email to my ex-husband as she could not get through to him.

She put our paperwork together and was going to also

get her senior boss to see what they could do.

On the 9th of January, she called me again at 1:36 PM and we spoke. She asked me to send a copy of my, divorce papers and the citizenship. She called again on the Wednesday (11th) asking to send more documents and I did as she instructed.

There were a few more documents that they asked for that I sent. Then, on the 27th Jan she called to say that she was going to try to process the passports and seek an exemption because usually they cannot approve passports if DNA testing has not been done.

She too said she was praying that her manager would approve it. In February, on the 5th we had the Testimony service that was on at 4:00 PM. When prophet Richard, papa, was praying and releasing grace, and people were sharing their testimony I received by faith because I knew what had been going on in my own home. It had been over a year just waiting on passports and they had kept telling me if they could not get in touch with my ex then there would be no passports.

People were sharing the testimony and I was receiving by faith because I know the God of my father. He has never failed me. I thanked him and prayed that February would not end without news. In fact I was praying that the week would not end without news. On the Monday after our prayer and fasting and the testimony service, I received a phone call around 8 35AM. I had just dropped off the kids to school and I was in the hospital because my leg had been swelling. The call came when I was sitting in the waiting area with one of my daughters and the lady said, "Guess what?" I said, "what?" I didn't know what she would say as I was thinking they would say no. In my heart I was thinking "God I have done everything. She said that on the Sunday evening, I was just going through your document and I have decided to issue the passports for your children because first of all, we don't know where your ex-husband is. You have been waiting for more than a year, getting to a year and three months. That is a long time waiting. So I decided to issue the passport on Sunday.

I had to ask her to repeat again, and she said around 7:00 PM on the Sunday she had been looking at our files

again and that is why she was calling me so early in the morning and even from her mobile number. The time she had been looking at our files was when our service was going on and people were testifying and I had been receiving it for my kids!! She said that from that point on, she would be the only person I'd deal with, and she would make sure the passports were approved, processed and sent off to us and we would not need to provide anything else.

This is what God has done. I have waited for these passports for one year and three months and this is God. There was a lot of delay and people were asking me how it could take one year and three months. I was not shaking, but now it has been approved without the DNA that they initially wanted from my ex-husband.

The woman said I did not deserve to go through so much because it was hard to get what was needed and I had done all I could. I told her that I was trusting God and she said that I was a blessed woman. And I said I bless God and I thank God.

If it had taken longer, I would have continued to pray! To see my children's passports now issued, on the 6th of Feb 2023. The passports arrived in the post on Monday the 13th of February. This is what God has done in my life. I just want to encourage family and friends that no matter the document you apply for, no matter what you have applied for your family, visa, immigration, passport, work, if they say they will get back to you, continue to believe, keep trusting God and keep receiving it that you will get the document. We went through a lot, and we were prophesying in faith that God would move. God did it for my children. He can do it for your family! He can do it for your friends. He can do it for your loved ones. Just be patient but continue to pray, continue to believe in him, continue to profess by faith.

They called me at a time that the offices are not yet open. I was crying while on the phone. Not because I was sad, but because of what God has done. People were wondering why I was crying, and I told them it was not because of anything but what God had done for me.
